#### Subscriptions & Payment Terms

When signing up for an annual subscription and usage of this system you are subject to the following terms;

- Two tier price structure according to your Dispex Ltd membership status at the time of sign up:
  - o One free account/register per member (offer commenced October 2021 and only from your renewal date thereafter). For members not due to renew, there is a 6 month FREE trial period, followed by a fee of £18+vat x the number of remaining months up until your membership renewal date, at which point it becomes free. ( Member Branch site(s), free 6 month trial followed by an annual fee of £216+vat)
  - o Non-members 3 months FREE trial period, followed by a £216 +vat annual subscription thereafter.

Subscriptions are charged on an annual basis, and payable via BACS

30 days before your **FREE** trial period ends, you will receive an invoice for the annual subscription which is payable via BACS before the **FREE** trial period ends, to continue using this service. If no payment is received by the due date as shown on the invoice, your access to the system shall be closed.

30 days before the end of your annual subscription period, you will receive a renewal invoice for the following years' access. Again, if payment is not received by the due date on the invoice, your access to the system shall be closed.

Invoices & reminders will be sent, via email, for payments to the email address you have supplied at the point of sign up.

NO refund will be made for a cancellation part way through an annual subscription including any changes to your Dispex Ltd membership status.

Each subscription is personal to the subscriber and is non-transferable.

Access to the CD Register system will be closed at the end of the FREE trial period, if no annual subscription is completed.

Access to the CD Register system will be closed at the end of the 12 months subscription, if no renewal is made.
